TO: ALL CANDIDATES FOR ELECTION TO SARANAC CENTRAL SCHOOL BOARD

THE EDUCATION LAW PROVIDES THAT CANDIDATES MUST FILE SWORN STATEMENTS WITH THE CLERK OF THE SCHOOL DISTRICT (AND THE COMMISSIONER OF EDUCATION, IF EXPENSES EXCEED \$500) AS TO THEIR CAMPAIGN EXPENSES. THE FORM ATTACHED IS A MINIMUM REQUIRED. IT FITS THE USUAL SITUATION IN SARANAC AS NO CANDIDATE HAS EVER SPENT AS MUCH AS \$500.

HOWEVER, YOU SHOULD BE AWARE THAT THE LAW REQUIRES YOU TO REPORT ALL MONEYS OR OTHER THINGS, PAID, GIVEN, EXPENDED OR PROMISED BY YOU, OR INCURRED FOR OR ON YOUR BEHALF WITH YOUR APPROVAL BY ANY PERSON, FIRM, ASSOCIATION OR CORPORATION, TO AID YOUR NOMINATION OR ELECTION, OR TO AID OR INFLUENCE THE NOMINATION OR DEFEAT OF ANY CANDIDATE TO BE VOTED FOR AT THE ELECTION. IT ALSO PROVIDES THAT NO PERSON OR PERSONS SHALL MAKE EXPENDITURES ON BEHALF OF A CANDIDATE WITHOUT HIS/HER APPROVAL UNLESS THE PERSON OR PERSONS FILES A SIMILAR STATEMENT REPORTING THAT THE CANDIDATE DID NOT APPROVE THE EXPENDITURE, WHICH MUST BE LIMITED TO \$25 AND MUST NOT BE INCLUDED IN COMPUTING THE SIZE OF YOUR OWN EXPENSES.

THE LAW REQUIRES FILING A FIRST STATEMENT ON THE 10TH DAY NEXT PRECEDING THE ELECTION. A SECOND STATEMENT MUST BE FILED WITHIN 20 DAYS NEXT SUCCEEDING THE ELECTION. A STATEMENT WILL BE DEEMED PROPERLY FILED WHEN IT IS DEPOSITED IN ANY ESTABLISHED POST OFFICE WITHIN THE TIME INDICATED ABOVE, DULY STAMPED, REGISTERED AND DIRECTED TO THE CLERK OF THE SCHOOL DISTRICT IN WHICH THE FILER IS A CANDIDATE (AND TO THE COMMISSIONER OF EDUCATION, IF EXPENSES EXCEED \$500).

ALL OF THE ABOVE MAY EVOKE MANY QUESTIONS. PLEASE CONSULT THE SCHOOL DISTRICT ATTORNEY FOR FURTHER INFORMATION.
