Code Requirements: In use food dispensing utensils improperly stored

Inspector Findings: Tongs used to dispence hamburgers and scoop used to serve baked beans were found stored on pan lid and not in hot held product. Corrected during inspection.

Additional Information Collected During Inspection

Comments: Comment: The facility has established standard operating procedures that ensure a safe food preparation setting. Temperature logs are maintained, the importance of time / temperature control is understood and routine cleaning is apparent. Inspector discussed "Ill Food Worker Policy" with Kitchen manager and the importance of not working with food when sick. Menu served on day of inspection included: Hamburgers, cheese, lettuce and tomatoes, baked beans, canned pears, yogurt and milk. Hamburgers are precooked and only require heating. Hot holding time is less than two hours and the food is placed on the serving line just prior to the arrival of the next wave of students. Preparing the lettuce and tomatoes involves washing, chopping and slicing which, requires barrier (gloves) when handling as a critical control point. Items checked during inspection included the following: accuracy of food probe thermometers, proper hot and cold holding, availability of handwashing in food preparation area, use of barrier (gloves) for handling "ready to eat" food, availability and proper concentration of sanitizer for wiping cloths, proper sanitizing by dishwasher, proper food and equipment storage and general sanitation.

Additional Information Collected During Inspection

Comments: Comment: No violations observed. Menu served on day of inspection included: chicken club sandwich, baked beans, yogurt and fruit (strawberries, blueberries and grapes) with gram crackers. The chicken is a precooked paddy that is heated and served on a hamburger roll with bacon and lettuce. The cafeteria staff heat up the chicken paddy throughout the 2 hour serving period, limiting the hot holding time. Items checked during inspection included: accuracy of food probe thermometer, availability of handwashing in a food prep area, use of barrier when handling "ready to eat" food. availability of sanitizer for wiping cloths and proper concentration of solution, proper sanitizing by dishwasher, proper food and equipment storage and general sanitation.


